SUBJECT: Activation of the 551st Strategic Missile Squadron (ICBM-Atlas)

TO: Commander-in-Chief, Strategic Air Command

- 1. The 551st Bombardment Squadron, Very Heavy, is redesignated as the 551st Strategic Missile Squadron (ICBM-Atlas), activated and assigned to Strategic Air Command for organization on or about 8 April 1961, at Lincoln Air Force Base, Lincoln, Nebraska, under an appropriate Unit Manning Document with capability as cited in O/T R1715S, 1 June 1958 (revised 1 July 1960), paragraphs 1 and 2b, Part I (Part IIC); strength, seventy-three (73) officers and four hundred and twenty-eight (428) airmen. This strength is not the authorized strength, but represents the total of the composition as cited in Part II of the O/T.
- 2. Personnel will be furnished from sources under control of the Commander-in-Chief, Strategic Air Command. Military personnel requirements which cannot be filled from within your resources will be requisitioned in accordance with normal cycle. A flow of personnel cannot be made available until seven (7) months subsequent to authorizations being reflected in the 5-AF-P2 report. Personnel manning will be phased in accordance with the unit's capability to utilize the personnel effectively.
- 3. For equipping purposes the above is a Category D unit and is authorized Unit Essential Equipment as listed in column 3A of MEAL, column 2A of T/A 010 and T/A 016 items in UME column of UAL. UME column of UAL will be prepared in conformance with paragraph 4c, Chapter 6, Volume XXI, AFM 67-1. Variable items, T/A 010, 016 and MEAL, will be based on UMD strength of unit. Base Support Equipment (BSE) as listed in column 3B of MEAL, and column 2B of T/A 010, is authorized in USE column of UAL. Unit is authorized additional equipment in USE column of UAL in conformance with paragraph 4d, Chapter 6, Volume XXI, AFM 67-1. BSE is not authorized as USE when a T/A item is on hand or on requisition which serves the same function as the BSE authorization, nor does it allow T/A allowances to duplicate BSE allowances.
- 4. Upon organization this unit is entitled to the history and to any battle honors, colors, and emblem belonging to the 551st Bombardment Squadron, Very Heavy, inactivated 27 June 1949. Unit history, with information provided by the Director of Military Personnel, Headquarters USAF concerning the existence of battle honors, colors, and emblem, will be forwarded to the Commander-in-Chief, Strategic Air Command by the USAF Historical Division, Air University through automatic distribution. Requisition for the appropriate colors can then be made as prescribed in AFR 35-75, 29 January 1954.

1. - (2) Distinguished Unit Citation Streamers for the following actions:
 - 17 August 1943 for outstanding performance of duty in action against the enemy over Germany General Orders 36, War Department, 1944
 - 12 May 1944 for outstanding performance of duty in action against the enemy over Germany General Orders 138, War Department, 1946
- b. Squadron emblem approved on 4 May 1943 (Atch 2). Procedures for changing and/or modifying approved emblems when the unit's mission is changed are outlined in AFR 900-3.
 - c. Unit's past record card (AFHQ Form 0-525) is attached (see Atch 3).
- 2. Request your activity prepare and forward history, with the information provided above, to the command to which the unit has been assigned. It is requested further that your historical records be checked to insure accuracy of battle honors. If any are added to our list, request a copy of your forwarding correspondence be furnished this headquarters (AFPMP-12-C) so that the Battle Honor files maintained by this headquarters may be corrected accordingly.

1. In accordance with AFR 900-3, 5 November 1959, the following emblem is approved for the 551st Strategic Missile Squadron (ICHM-Atlas), to supersede the emblem approved under a former designation, the 551st Bombardment Squadron (H), 4 May 1943:

<u>DESCRIPTION</u>: On a sky blue disc edged Air Force blue, bendwise throughout a mailed hand issuing from sinister (left) bese, dark gray, shaded black, highlights white, grasping a drawn bow red, with arrow white, shaded black, the taut string black.

MOTTO: On a white scroll edged and inscribed Air Force blue, STRENGTH MAINTAINS SECURITY.

SIGNIFICANCE: The emblem is symbolic of the squadron and its mission. The missile is the weapon system used by the unit as part of SAC's deterrent force. The drawn bow symbolises the potential instantaneous release of destruction against an aggressor. This state of preparedness is maintained by the squadron. The mailed hand illustrates the firm human controlling agent of the force. The background represents space, the medium in which the missile force operates.

2. Attached is the official painting of the emblem described above, to be forwarded to the unit for file and guidance in reproduction.
